Calcium chloride is produced from natural brine deposits found underground. It attracts moisture; this is what makes it an excellent dust control agent.

**SFG does NOT guarantee complete suppression of dust, because of weather, traffic and road conditions may affect the treated area. Two applications are highly recommended. It is dust control, not complete dust elimination.**

Flags may be picked up at the Lucas County Engineer's office, SFG offices in Albia or Knoxville, and must be in place from May 1<sup>st</sup> to October 1<sup>st</sup>. Flags should be placed approximately 6' from the edge of the road on the traffic side for easy visibility. Failure to maintain stakes may result in a loss of dust control.

Our trucks are equipped with computer equipment that measures the exact footage being sprayed. If the flags are not set to the correct footage purchased, we will go to the purchased footage. If the area is not marked by flags the driver will use their best judgment for the treated area.

Weather permitting, we plan to apply dust control around May 23<sup>rd</sup>-28<sup>th</sup>. The second application will be sprayed around July 18<sup>th</sup>-23<sup>rd</sup>. **If you want two applications both must be turned in by due date.** Product SDS sheets are available upon request at Smith Fertilizer & Grain.

This will be done without prior notice to the applicant, to restore the treated section of the road to satisfactory driving surface.
- 2.) The undersigned applicant hereby covenants and agree to accept any and all liability in connection with any accident, which might result at the time of the application of the dust control or any accident which might occur at a future date as a result of the treated condition of the road.
- 3.) The undersigned hereby covenant and agree to indemnify Lucas County for any liability which might occur because of the treated condition of the road in consideration of Lucas County's permission to the undersigned to treat said road.
- 4.) This agreement will become effective May 1<sup>st</sup> of the present year and will expire on October 1<sup>st</sup> of the present year.
