Calcium chloride is produced from natural brine deposits found underground. It attracts moisture; this is what makes it an excellent dust control agent. SFG does NOT guarantee complete suppression of dust, because weather, traffic and road conditions may affect the treated area. Two applications are highly recommended. It is dust control, not complete dust elimination.

Flags may be picked up at, Marion County Engineer's Office, County Shops, or the Central Shop. Flags must be in place at each end of the area to be treated and readily visible but not right along the road in the maintainer's way. Failure to maintain flags may result in loss of dust control. Flags must be in place from April 15th to October 1st.

Our trucks are equipped with computer equipment that measures the exact footage being sprayed. If the flags are not set to the correct footage purchased, we will go to the purchased footage. If the area is not marked by flags the driver will use their best judgment for the treated area.

Weather permitting, we plan to apply the first application on/around May 1st-31st. The second application will be sprayed on/around July 15th-31st. Product SDS sheets are available upon request at Smith Fertilizer & Grain.

CUSTOMER RESPONSIBILITIES PER COUNTY

- 1.) Homeowner shall follow deadlines established for requesting dust control. No exceptions.
2.) Homeowner shall be responsible for maintaining the dust control area by filling potholes that may develop as soon as possible, and within three days if notified by Marion County. Loose material from the edge of the road may be used to fill potholes. If not properly maintained, the County reserves the right to smooth and maintain at the district foreman's discretion.
3.) Homeowner shall understand that after October 1st of each year, dust control areas are routinely bladed as a normal preparation for winter. Dust control areas may also be maintained at any time deemed necessary for the convenience of travelers on the public road. Marion County will not be responsible for the loss of effectiveness of the dust control treatment. In such cases the individual paying for the dust control may have the dust control reapplied at any time.
4.) Homeowner shall assume full responsibility for all liability resulting from the dust control material placed upon the county roadway.
5.) Homeowner shall understand that by purchasing the dust control services, the customer agrees to abide by the conditions stated in this document.
6.) Homeowner shall understand that any complaints regarding the performance of the dust control product shall be directed to the applicator, not to Marion County.
